The ESOP Plan involves only secondary acquisitions of shares of the Company from the recognised stock exchange for cash consideration by TVSM Employees Stock Option Trust ("**Trust**"). No fresh shares shall be issued by the Company either to the Trust or to the grantee under the ESOP Plan. The Trust may acquire for the purpose of implementation of the Scheme, in one or more tranches, such number of shares of the Company from the secondary market, not exceeding 0.25% (zero point two-five percent) of the paid-up equity share capital of the Company as at 31st December 2023.
